1. *Crime and Patrol Summary*

See attachments. The department responded to 1,213 requests for service during the month of July. Community Service responded to 167 requests for service.

For this month, both School Resource Officers were assigned to patrol for the summer, which increased our staffing levels in patrol. With the additional staffing, we have been able to handle the increased calls for service and provide more traffic enforcement. We have received numerous complaints of improper driving throughout the city and we have been able to focus on traffic enforcement. The patrol division has provided traffic enforcement in areas that we have received complaints for improper driving. Several citations and warnings have been issued to drivers in these areas. We have also have directed traffic enforcement to the construction zone on the east side of town. Several citations have been issued for speeding in this area. With the additional traffic enforcement we have been able to provide the community and construction workers a safer environment to drive and work. We will continue to provide traffic enforcement for the month of July in the areas of the citizen concerns along with the construction zones.

Patrol officers are always the first responders; and do the initial investigations and crime scene security for cases like those mentioned in the Investigations Activity.


