

**ORDINANCE NO. 1054 (2016)**

**AN ORDINANCE OF THE CITY OF CRAIG, COLORADO AMENDING THE NOISE ORDINANCE PERTAINING TO NOISE PERMITS AS CONTAINED IN SECTION 9.42.060 OF THE CRAIG MUNICIPAL CODE**

**RECITALS**

WHEREAS, the noise ordinance as contained in Section 9.42.060 contains a process for permits for using sound-amplifying equipment which will be amended to include a noon deadline requirement prior to issuance and to correct the citation to the maximum sound levels allowable.

**WHEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CRAIG AS FOLLOWS:**

Section 1. Section 9.42.060 (A) and (C) shall be amended to state in part as follows:

**9.42.060 Permits for using sound-amplifying equipment.**

A. An application for a permit shall be directed to the city manager or his designee no later than noon (12:00 p.m.) of the day of the requested beginning time of the requested permit, and shall provide the following information:

1. The name, address and telephone number of both the owner and user of the sound amplifying equipment;
2. The license number of a vehicle which is to be used, if any;
3. The general description of the sound-amplification equipment which is to be used;
4. Whether the sound-amplifying equipment will be used for commercial or noncommercial purposes; and
5. The dates, times and location, and the streets over which, the equipment is proposed to be operated.

C. 2. The maximum sound emanating from the sound-amplifying equipment shall not exceed the sound levels established in Section 9.42.030 as measured twenty-five (25) feet from the noise source.

Section 2. EFFECTIVE DATE: This Ordinance shall take effect ten (10) days after passage and upon publication of such ordinance after passage.

Section 3. PUBLICATION BY SUMMARY: The City Council deems it appropriate to publish the title of this Ordinance, together with a summary of the Ordinance and with the statement that the text is available for public inspection and acquisition in the office of the City Clerk.

Section 4. PUBLIC PURPOSE: The City Council of the City of Craig herewith finds and determines that this Ordinance is necessary for the preservation of the public peace, health and safety. This Ordinance is enacted pursuant to the City's authority to act under its police power to protect and preserve the general welfare of the City and its citizens.
